

Notes from the CEO

A new chapter has been written in the long-running dispute over groundwater pumping charges between the city of Ventura and United Water Conservation District (UWCD). And this time, the storyline decisively favors farmers.

The saga began nearly four years ago, when UWCD adopted an increase in its groundwater extraction charges.

The city sued, challenging the legality of the rate structure, which charges urban users three times as much per unit of water as it does agricultural users.

The ratio is not arbitrary. Under the California Water Code, UWCD is legally required to charge urban pumpers at least three times as much as agricul-

tural pumpers. That's been state law since 1963, and the district is not free to disregard it.

The revenue generated by the fee pays to maintain and operate facilities critical to the sustainability of a water supply that serves more than half the county's irrigated agricultural acreage, as well as the military bases, major industrial employers, and tens of thousands of residents in Ventura, Oxnard, Santa Paula, Fillmore, Port Huen-

eme and the beach communities. These facilities include Santa Felicia Dam, the Freeman Diversion, and a variety of pipelines and percolation basins with a single overarching purpose: to ensure that all these users – city dwellers and crop irrigators alike – may continue to rely on the shared groundwater resource without destroying it.

In its filing, the city made a number of claims, including that it derives little or no benefit from the district's groundwater protection and recharge activities. The city also contended that the groundwater

extraction charges are unconstitutional because UWCD did not specifically demonstrate that the differential rates are proportional to the costs of service to each class of user. The city argued that such proportionality is required by Proposition 218, a constitutional amendment approved by voters in 1996, and that the Water Code requirement is therefore unconstitutional.

Farm Bureau of Ventura County and the California Farm Bureau Federation intervened in the case to defend the Water Code's 3-1 ratio requirement, which is of critical importance to agricultural interests statewide.

In April 2013, a Santa Barbara trial court judge dismissed most of Ventura's claims, including its suggestion that the Water Code is unconstitutional. He did rule, however, that the groundwater extraction charges were subject to the Proposition 218 proportionality requirement, and that UWCD had failed to demonstrate that urban users derive three times as much benefit from its activities as agricultural pumpers when it adopted those rates. He ordered United to pay back more than a million dollars to the city.

Both parties appealed the ruling. United argued that Proposition 218 does not apply to the groundwater extraction charge. The city sought to have the Water Code section requiring the rate differential to be declared unconstitutional, and to force UWCD to change its method of calculating the extraction charge. Instead of charging a uniform rate across all groundwater basins for activities related to recharge and conservation, as UWCD historically has, the city sought to force the agency to calculate what percentage of the benefit from each of those activities can be demonstrated to flow directly to each individual basin – probably impossible from a hydrogeologic standpoint, and certainly a nightmare from an accounting standpoint.

On March 17, the Second District Court of Appeal ruled in United's favor on every count. It reversed the trial court decision in favor of the city and, most crucially, ruled that the groundwater extraction charges are neither property-related fees nor taxes – meaning they are not subject to Proposition 218's proportionality requirements or to approval by the voters.

Part of your responsibility is to control potential workplace hazards and correct hazardous conditions or practices as they occur or are recognized. The IIPP includes a system for you to communicate with your employees on matters relating to occupational safety and health, including provisions designed to encourage employees to inform you of hazards at the worksite without fear of reprisal.

An effective IIPP should establish the following requirements for a safe workplace:

- Management commitment and assignment of responsibilities.
- Safety communications system with employees.

- System for assuring employee compliance with safe work practices.

- Scheduled inspections and an evaluation system.
- Accident investigation.
- Procedures for correcting unsafe and/or unhealthy conditions.
- Safety and health training and instruction.

- Recordkeeping and documentation.

The court also found that the charges are "fair and reasonable," and do not exceed UWCD's resource management costs.

It was a complete legal smackdown of the city. For agricultural pumpers, the victory preserves a rate structure that provides substantial benefits. Had UWCD been forced to equalize its extraction charge across all categories of users, it would have nearly doubled the rates for agricultural users.

It's also a victory for farming interests statewide, preserving the benefits of the Water Code for groundwater pumpers in numerous other basins managed by water conservation districts. And those benefits likely will expand dramatically in coming years, as hundreds
