## Nitrogen Forms

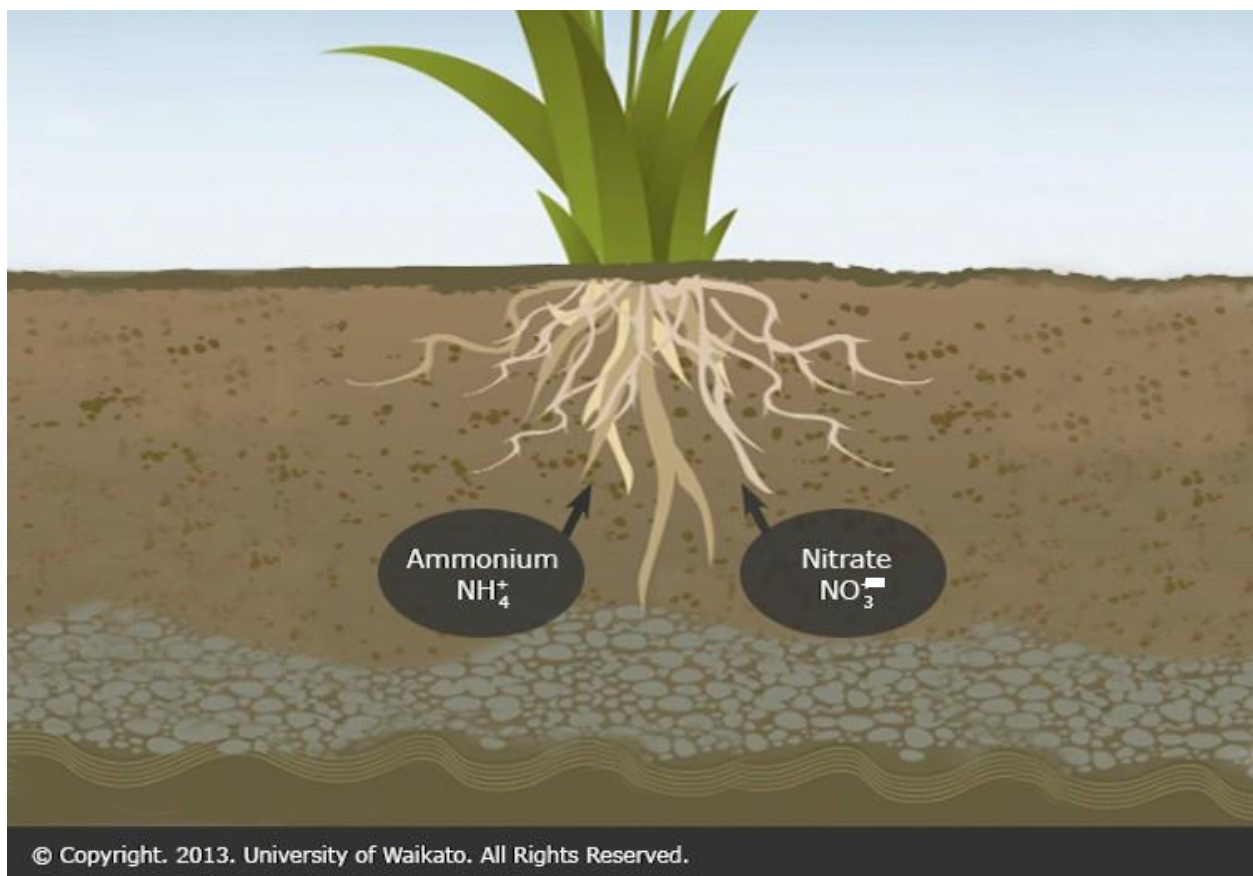
---

Nitrogen is one of the most abundant elements on Earth. However, not all forms of nitrogen are available to crops. Nitrogen exists in agriculture in two general forms:

1. Organic Nitrogen:
  - When carbon and nitrogen molecules are linked together
  - Must be transformed to be available to crops
2. Inorganic Nitrogen:
  - Some are directly available to crops like ammonium and nitrate
  - Some like nitrogen gas must be transformed to be available to crops

### Crop Available Nitrogen

Crops can take up ammonium and nitrate from the soil. However, nitrate is used more often by crops in agricultural soils. This is primarily because ammonium quickly converts to nitrate in the soil making nitrate the main form available. Also, because nitrate has a negative charge and moves easily through the soil with water.

### Nitrogen Cycle Overview

---

In agricultural systems, nitrogen moves in and out of different environmental spheres. These spheres include the atmosphere, lithosphere, biosphere, and hydrosphere. The movement of nitrogen between environmental spheres is called the *Nitrogen Cycle*.

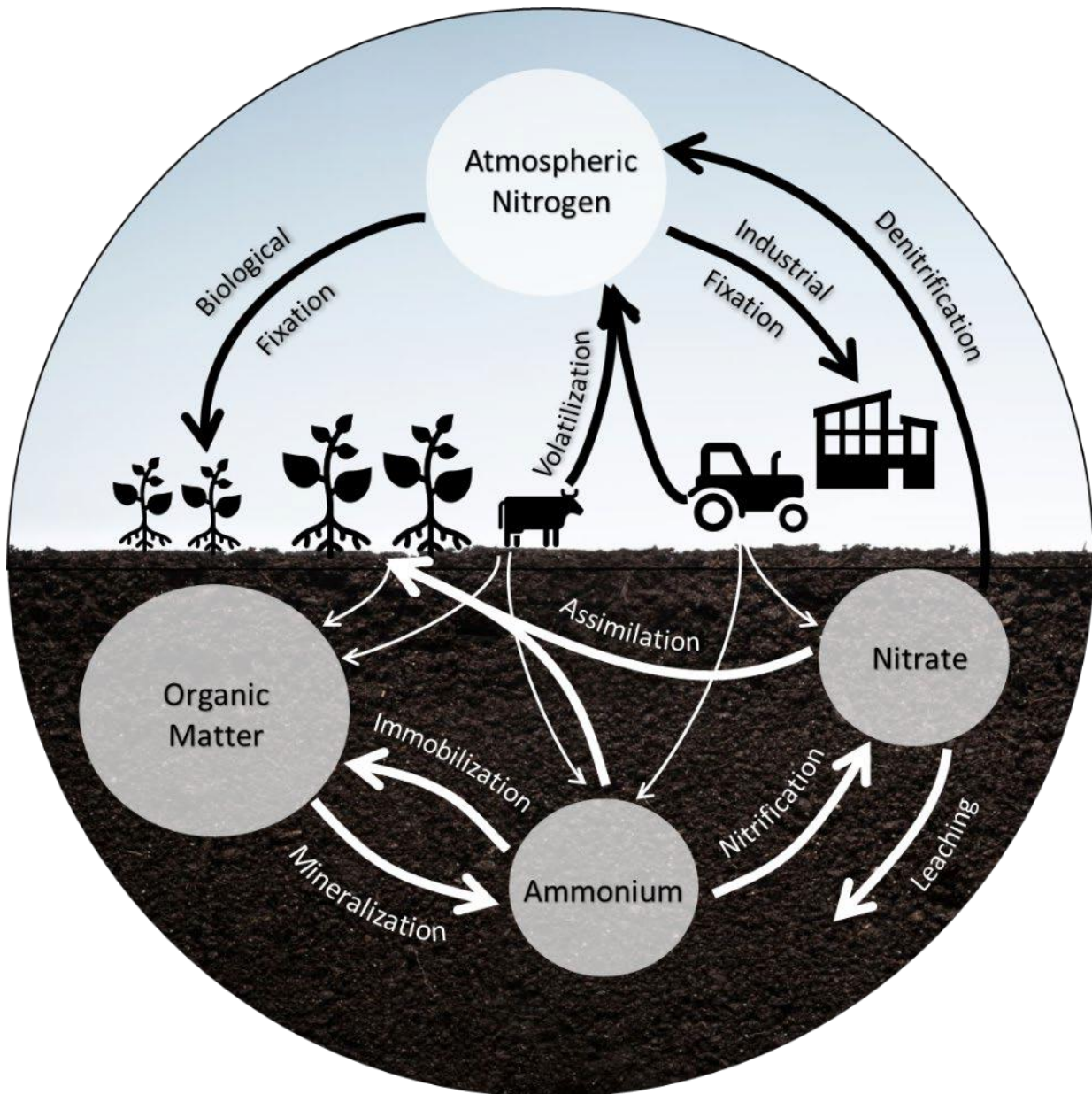

## Nitrogen Transformations

As nitrogen moves through the cycle it is transformed readily from one form to another. These transformations make up the heart of the nitrogen cycle. Nitrogen transformations include fixation, mineralization, immobilization, nitrification, and assimilation.



## Nitrogen in the Air

---

Earth's atmosphere is 78% nitrogen gas. However, nitrogen gas cannot be used directly by crops. It must first go through a transformation process called *nitrogen fixation*. In agricultural systems, there are two main ways that nitrogen fixation occurs.

1. Biological Fixation- On legumes like alfalfa, microbes living in root nodules transform nitrogen gas into ammonium which can be used by the crop. Additionally, some free-living soil microbes can also fix a small amount of nitrogen.
2. Industrial Fixation- Humans combine nitrogen gas and hydrogen gas to make ammonia which is used to manufacture nitrogen-based fertilizers.

## Nitrogen in the Soil

---

The soil contains both organic and inorganic nitrogen. To be used by crops, organic nitrogen must be transformed.

### Soil Microbes

In the soil, microbes like bacteria and fungi transform nitrogen from one form to another. Microbe activity depends on several factors such as soil moisture, temperature, pH, and oxygen. When the soil is moist and warm, microbes are more active and nitrogen transformations will occur faster.

### Soil Organic Matter

Many microbes in the soil decompose organic matter for energy. Organic matter includes crop residues, organic inputs like compost, and soil organic matter. Soil organic matter forms over time from microbial, plant, and animal residues.

These residues contain carbon and nitrogen. The amount of carbon present in the material compared to the amount of nitrogen present is called the carbon-to-nitrogen (C:N) ratio. A C:N ratio of 20:1 means that there are 20g of carbon for each 1g of nitrogen in the residue. The C:N ratio determines how fast microbes will decompose the residues.

### Nitrogen Mineralization

Residues with a low C:N ratio (less than 20:1), are decomposed quickly by soil microbes. Any nitrogen that the microbes do not use will be released back into the soil as ammonium. This process is called *nitrogen mineralization*. These residues include cover crops, legumes, and raw and composted animal manures.



## Nitrogen Immobilization

Residues with a high C:N ratio (greater than 20:1) are decomposed slowly by soil microbes. If the C:N ratio exceeds 35:1, microbes will consume additional inorganic nitrogen from the soil to break down the carbon. This can decrease the amount of nitrogen available to the crop. This process is called *nitrogen immobilization*. Many crop residues have high C:N ratios like corn stover, straw, and tree prunings.

## Nitrification

Another group of microbes in the soil gain energy by transforming ammonium into nitrate. The nitrate is then released into the soil. This process is called *nitrification*. On average, ammonium is transformed to nitrate within weeks when soils are warm and moist.

## Nitrogen in Plants

---

Crop uptake is the most beneficial use of nitrogen in agricultural systems.

### Nitrogen Assimilation

Crops use ammonium and nitrate to form amino acids, chlorophyll, enzymes, and nucleic acids. This process is called *nitrogen assimilation*.

## Nitrogen Losses

---

Excess nitrogen in the soil that is not used by crops, cover crops, or microbes is susceptible to loss. Thus, overapplication of nitrogen can be damaging to a grower's profit and the environment. Potential loss pathways include nitrogen leaching, volatilization, and denitrification.

### Nitrate Leaching

Nitrate ( $\text{NO}_3^-$ ) has a negative charge. Thus, it is not held by clay particles and moves easily through the soil with water. Nitrate that leaches past the root zone is unavailable to crops and can contaminate groundwater. Leaching is a major loss mechanism, especially in coarse-textured soils.

### Denitrification

Saturated or waterlogged soils have low levels of oxygen. Some soil microbes can consume nitrate ( $\text{NO}_3^-$ ) in place of oxygen. In this process, called *denitrification*,  $\text{NO}_3^-$  is converted to gaseous forms of nitrogen. Denitrification mostly results in  $\text{N}_2$  gas which is harmless. However, denitrification can also result in nitrous oxide which is a potent greenhouse gas. This is a normal and unavoidable occurrence in irrigated agriculture. Though, denitrification can be reduced with management practices.

### Ammonia Volatilization

Nitrogen sources containing urea can be susceptible to significant loss, especially when left on the soil surface. These sources include manure and UAN. When urea breaks down, ammonia ( $\text{NH}_3$ ) is produced. The ammonia can escape to the atmosphere unless it reacts with water to form ammonium ( $\text{NH}_4^+$ ). The loss of nitrogen to the atmosphere as ammonia gas is called *volatilization*. *Ammonia volatilization* is most likely to occur when soils have a high pH, are moist and warm, and/or the nitrogen source is surface applied.

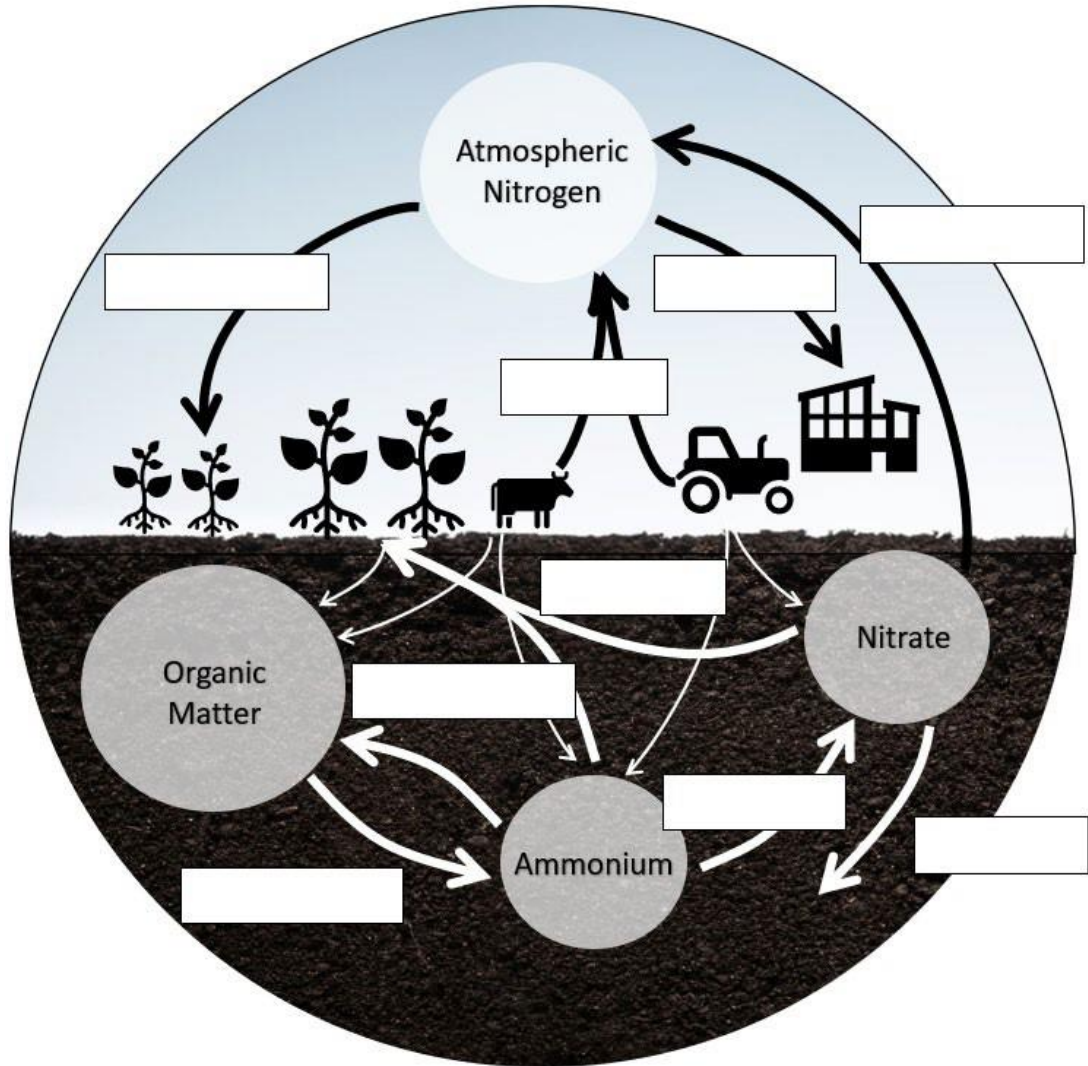
## Module 1 Lesson 1 Summary

---

## Impacts of Nitrogen Loss on the Environment and Human Health

---

While nitrogen is essential for crop growth, applying too much nitrogen can be damaging to the environment and human health, as well as your profit. Excess nitrogen can also lead to crop production issues like excess vigor and increased susceptibility to disease.

### Nitrogen in the Atmosphere

Nitrous oxide is a powerful greenhouse gas produced by microbes during the nitrification and denitrification processes. Nitrous oxide is roughly 300 times more potent in warming the climate than carbon dioxide. This means that even a small amount of nitrous oxide produced by microbes can have a large impact. Nitrous oxide can damage the ozone layer of the atmosphere. The ozone layer protects Earth from damaging ultraviolet radiation.

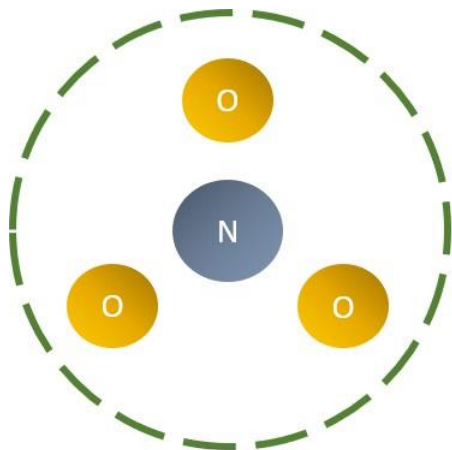
### Nitrate in Drinking Water

When nitrate leaches below the root zone, it can contaminate groundwater. High levels of nitrate in the groundwater can cause illness when used for drinking. Nitrate reduces the blood's ability to carry oxygen. This is especially dangerous for infants under six months of age and pregnant woman. Symptoms include shortness of breath and the appearance of blue skin from the lack of oxygen in the blood. Nitrate in drinking water can also be damaging to livestock.

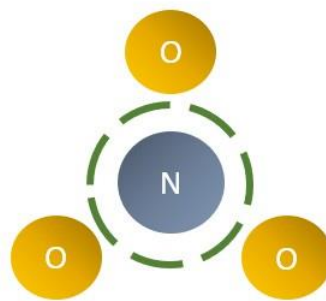
## Measuring Nitrate in Drinking Water

---

When nitrate is measured, it is either reported as nitrate or nitrate-nitrogen. When reported as nitrate, the weight of the nitrogen atom and the three oxygen atoms are reported. When reported as nitrate-nitrogen, only the weight of the nitrogen atom is reported.

Nitrate-Nitrogen ( $\text{NO}_3\text{-N}$ )

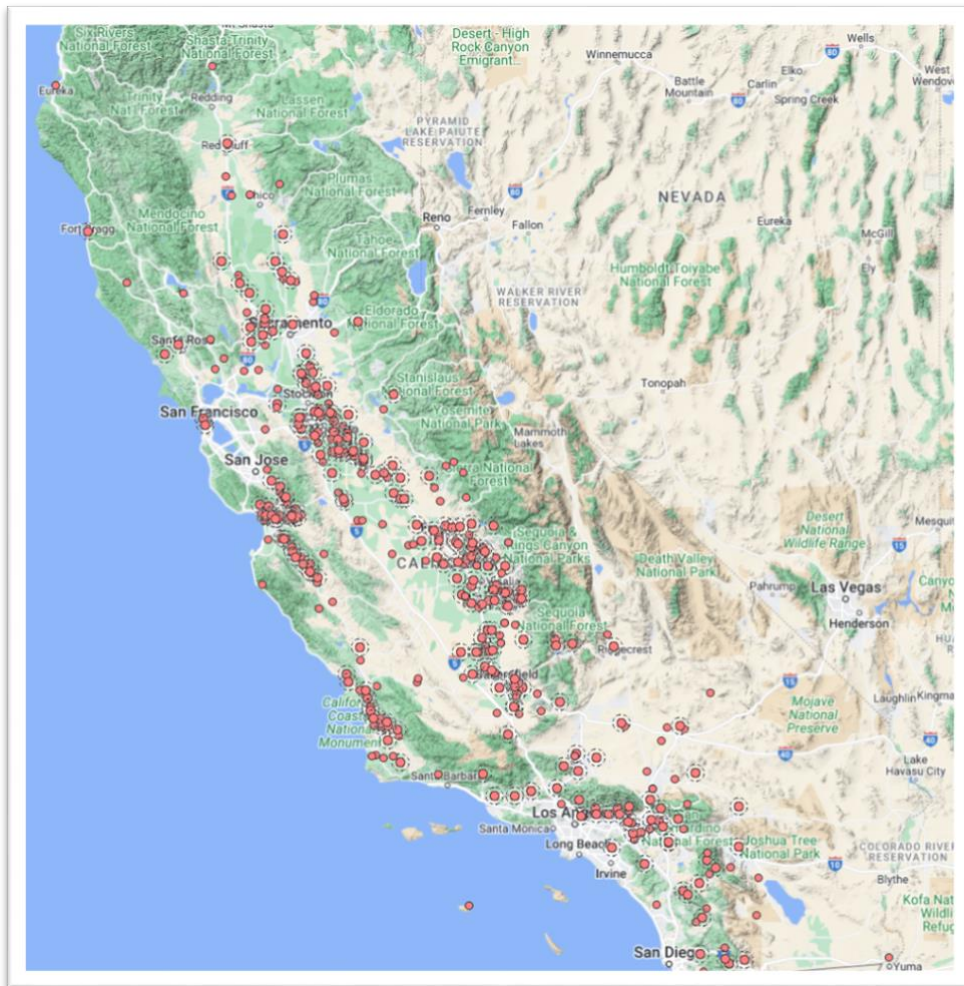
## Maximum Contaminant Level

Due to the possible impacts on human health, the United States Environmental Protection Agency (EPA) has set a standard for nitrate levels in drinking water. The Maximum Contaminant Level for Nitrate-nitrogen is 10 mg/L or 10 parts per million (ppm). This is equivalent to 45 ppm nitrate.

## Nitrate Contaminated Drinking Water

Nitrate contaminated groundwater can be found in agricultural areas throughout California. Nitrate contamination disproportionately affects low-income communities and communities of color. The California State Water Resources Control Board has an interactive map to determine if your well is near a known nitrate impacted well.

## **Irrigation and Nutrient Management Plan (INMP) & Irrigation and Nutrient Management Report (INMR)**

---

To comply with ILRP nitrogen management reporting requirements growers must complete the following forms:

- Irrigation and Nutrient Management Plan (INMP) Worksheet
- Irrigation and Nutrient Management Report (INMR)

### **INMP Worksheet**

The INMP worksheet was designed to help growers increase the efficiency of irrigation and nitrogen applications. One or more INMP Worksheets must be completed for each parcel enrolled under the ILRP. Worksheets are kept on-farm and must be certified.

### **INMR**

The INMR was designed to help monitor nitrogen applied and removed from the field through harvest. INMRs are submitted annually to the coalitions. The coalitions compile and anonymize the data prior to submitting it to the Regional Water Quality Control Board.

### **Certification Exemptions**

Growers with total farming operation acreage less than 10 acres are exempt from the requirement to certify an INMP. However, they are still required to develop an INMP and submit an INMR.

### **Alternative Reporting**

Growers who meet one of the following qualify for INMR alternative reporting. Alternative reporting requires reporting of all nitrogen and irrigation application, but does not require reporting of harvest yield.

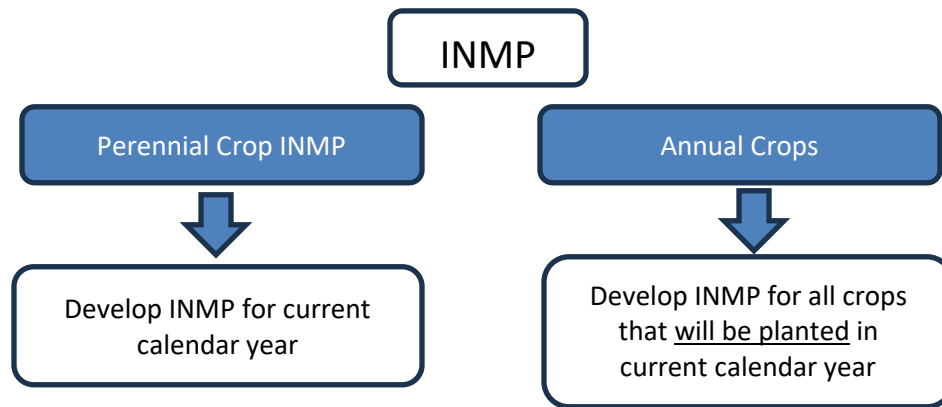
1. Growers that (1) operate in areas with evidence of no or very limited nitrogen impacts to surface water or groundwater, (2) have minimal nitrogen inputs, **and** (3) have difficulty measuring yield
2. Diversified socially disadvantaged growers, as defined by the Farmer Equity Act of 2017, with (1) a maximum total acreage of 45 acres, (2) gross annual sales of less than \$350,000, and (3) a crop diversity greater than 0.5 crops per acre (one crop for every two acres).
3. Growers with (1) a maximum total acreage of 20 acres, and (2) a crop diversity greater than 0.5 crops per acre (one crop for every two acres).

## INMP & INMR Deadlines

---

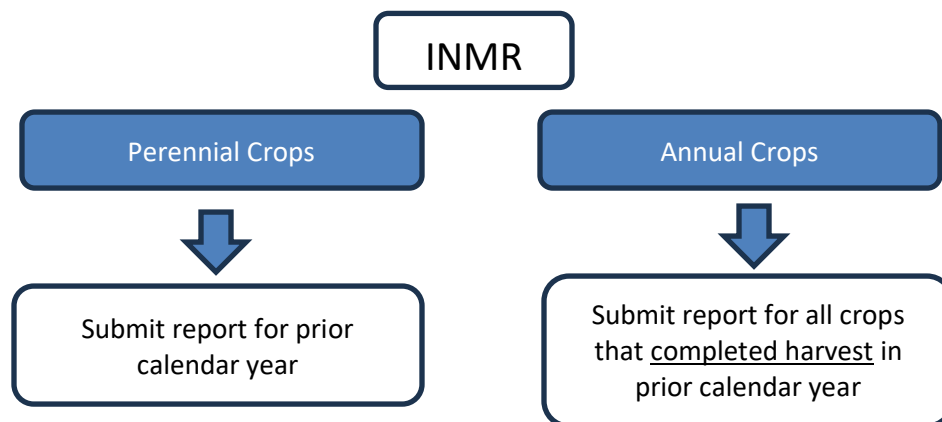
**Deadline to develop initial INMP:** **March 1, 2025** annually thereafter

- **Perennial Crops:** Develop an INMP for the current calendar year. The first INMP will cover the 2025 calendar year.
- **Annual Crops:** Develop an INMP for all crops that will be planted in the current calendar year. The first INMP will cover all crops planted in 2025.



**Deadline to submit initial INMR:** **March 1, 2026** annually thereafter

- **Perennial Crops:** Submit a report for the previous calendar year. The first INMR, due in 2026, will cover the 2025 calendar year.
- **Annual Crops:** Submit a report for all crops harvested in the previous calendar year. The first INMR, due in 2026, will cover crops that completed their growth cycle (planted and harvested) in 2025.
- **Note on 1<sup>st</sup> year reporting for annual crops:** If crops planted in 2025 were not harvested by the end of the year, an INMR stating “no completed crop cycle in 2025” must still be submitted. Subsequent INMRs will include all crops harvested in the prior calendar year, even if planted earlier.



**INMR Submittal**

INMRs must be submitted to the coalition by the deadline outlined above. VCAILG offers an online platform for submitting INMRs. Please check with your coalition prior to the deadline to determine what submittal options are available.

## Outlier Identification Process

---

### Step 1: Data Submitted

INMR data is collected annually by coalitions.

### Step 2: A/R Ratio and A-R Difference Calculated

Coalitions use the data from INMRs to calculate the ratio of nitrogen applied (A) to nitrogen removed (R) for each field. A/R and A-R are both used as metrics to determine the potential for nitrogen loss.

- Nitrogen Applied: includes nitrogen from fertilizers, organic amendments, and irrigation water.
- Nitrogen Removed: includes all harvested materials removed from the field. Calculated based on yield and a nitrogen removal coefficient

### Step 3: Data Compared Across VCAILG

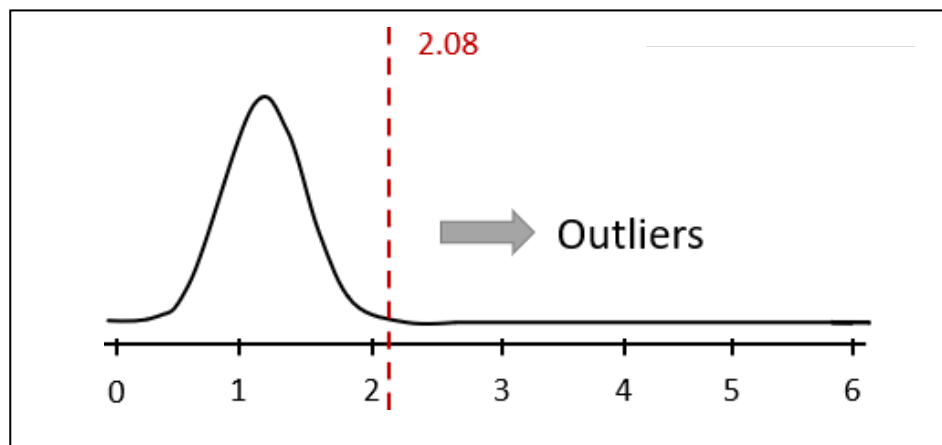
A/R or A-R values are compared across members for each crop in the coalition's area.

### Step 4: Outlier Threshold Calculated

A threshold value is determined based on all collected data. Any fields with A/R or A-R values above the threshold are considered outliers.

### Example

The graphic below shows an example distribution of A/R values for an individual crop type. The peak of the curve represents the calculated A/R value for most growers. The red dashed line represents the calculated threshold value. A/R values to the right of the calculated threshold value are considered outliers. The growers with fields that have an outlier A/R value are notified of their outlier status by the coalition.



## **Reasons for High Values**

There are several reasons a field may have a high A/R or A-R value resulting in outlier designation:

- Nitrogen applications are greater than the crop demand
- Inefficient applications of nitrogen or irrigation water
- Reduced yields due to pest or weather damage
- Crop failure or loss
- Errors were made in data submitted in INMRs

## **Step 5: Notification**

Members receive notification of where their management units are in comparison to other growers in the coalition. Members with management units designated as outliers will also receive information about additional requirements.

## **Purpose of Identifying Outliers**

---

Being an outlier is an early indicator that excess nitrogen is being applied to a management unit. Identifying outliers can help the coalition and members work together to implement improved management practices.

## **Additional Requirements for Outliers**

---

Members that have one or more outlier management units are subject to additional requirements. Additional requirements may include:

- Indicate “previously identified as outlier” on INMR
- Attend focused education meetings
- Cannot claim INMP certification exemption (for those previously exempt due to operating <10 acres)

## Management Units

---

A management unit can be either a group of parcels, fields, or blocks or a subset of a parcel that is treated the same and have similar characteristics. A management unit has the same crop, age (for perennial crops), nitrogen and irrigation inputs, and management practices and is comprised of contiguous land.

### Perennial Crop Example

- 85 acre lemon orchard
- Covering 4 parcels
- Same age
- Same nutrient and water inputs

### Annual Crop Example

- 30 acre vegetable field
- Rotations of cilantro, peppers, and cabbage
- Each rotation receives same nutrient and water inputs

### APN- Assessor’s Parcel Number

---

An assessor’s parcel number (APN) is a unique number that a tax assessor assigns to a parcel in a county. It is used by the county for record-keeping and to track ownership of the land. Be sure to include any dashes or zeros in the APN.

#### Where to Find Your APN

Your APN can be found on your property tax bill or through your county assessor’s office or website. For leased land, the APN may be listed on the lease or available through the property owner.

#### Reporting Multiple APNs

If your management unit contains multiple APNs, list each APN with its respective irrigated acreage. The irrigated acreage listed may include a portion of the parcels total irrigated acreage if there are other management units on the same parcel. For each APN listed, include only the irrigated acreage that is being covered by the management unit for which the INMP is being developed.

## Standard Crop Name

---

Nitrogen removal coefficients, used to calculate nitrogen removed from the field, are unique for different crops and harvest methods. Thus, using a standard name for reporting ensures a fair evaluation of nitrogen applied vs. removed.

### Standard Crop Name List

VCAILG has a draft list of standard crop names available to growers. In the online member portal, crop names will be presented in a drop-down list. If a crop name is not on the current list, growers can reach out to their coalition to request assistance.

## Crop Age

---

Reporting crop age or year planted is required for perennial crops.

Crop age influences expected yield, nitrogen applied, and nitrogen removed with harvest.

Information on the INMP Worksheet and INMR is based on the calendar year in which harvest was completed. For example, if citrus harvest is completed May 2023 the crop age is reported for 2023, regardless of what year fertilization occurred.

## Irrigation and Nitrogen Management

---

Nitrate moves easily through the soil profile with water. Thus, poor irrigation management can reduce the efficiency of nitrogen fertilizer applications. Irrigation applications exceeding crop ET can result in nitrate leaching to the groundwater.

## Irrigation Efficiency

---

Irrigation efficiency (IE) is the percentage of applied water that is beneficially used. Beneficial uses include meeting crop water demand, salt leaching requirements, and climate control. The main factors that influence irrigation efficiency are: (1) distribution uniformity, (2) irrigation timing and amount, and (3) system maintenance.

### **Typical Irrigation Efficiency Ranges**

Typical irrigation efficiency ranges for different systems can be found in the table below.

<b>Irrigation Method</b>	<b>Typical Efficiency Ranges (%)</b>
Microsprinkler	85-90
Surface Drip	85-90
Subsurface Drip	80-90
Solid Set Sprinkler	70-85
Hand Move Sprinkler	65-85
Furrow	55-75
Basin	60-75

## Distribution Uniformity

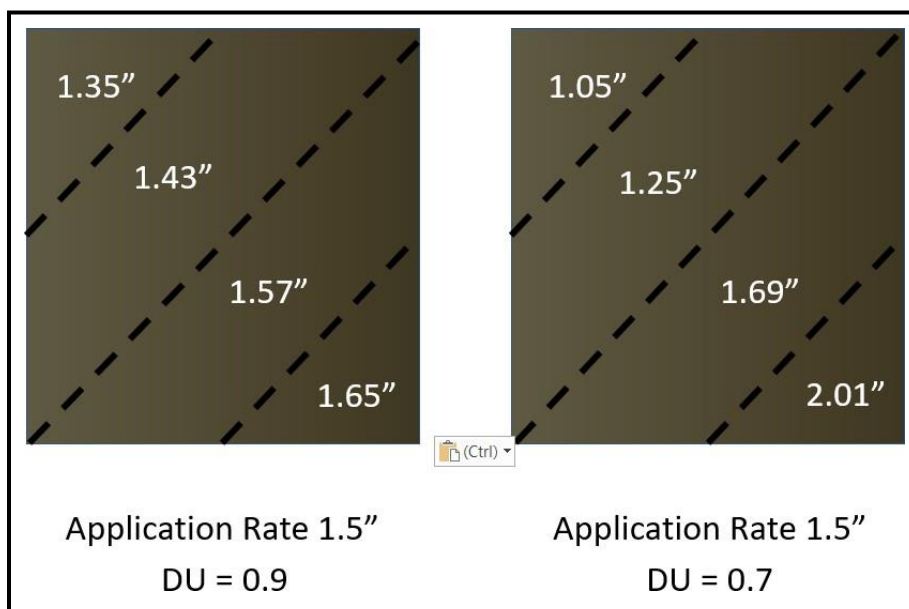
---

Distribution uniformity (DU) is a measure of how evenly water is applied to a field. When irrigation water is applied uniformly, irrigation efficiency will be high if the timing and duration of each irrigation is appropriate.

DU is expressed as a value between 0.1-1.0. A good DU for drip, microsprinkler, and sprinkler systems is above 0.85. Anything less than 0.8 is considered a poor DU. In flood, furrow, and basin systems a good DU is above 0.7.

### Distribution Uniformity Example

In the example below a grower applies 1.5" of water to a field. The example shows the effect of DU on the amount of water applied to different portions of the field. With a poor DU, more water is applied than is needed, to ensure that the "low quarter" gets adequate water. And even then, it might not be enough.



### Testing Distribution Uniformity

Many organizations that specialize in irrigation systems and maintenance will offer irrigation system evaluations.

Some Resource Conservation Districts (RCD) offer free or discounted irrigation evaluations for growers in their area. As part of the evaluation the RCD may provide measurements of DU and application rates. <https://www.conservation.ca.gov/dlrp/RCD/Pages/CaliforniaRCDs.aspx>

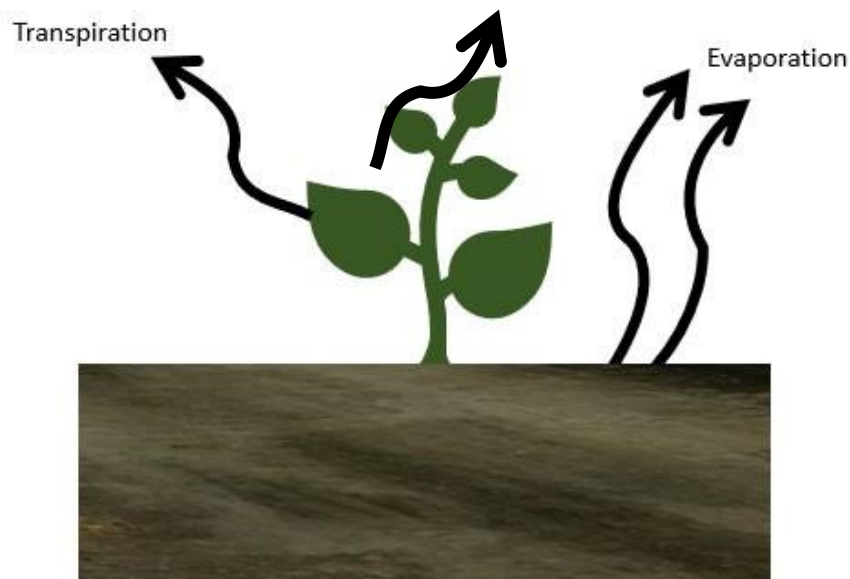
## Crop Evapotranspiration

### INMP Worksheet Box 1

Evapotranspiration (ET) is a combination of evaporation and transpiration. Evaporation is the loss of water from the surface of the field. Transpiration is the loss of water from the plants' stomata (pores). ET varies geographically and is influenced by the weather, soil, and plants.



## Estimating Crop Evapotranspiration (ETc)

---

ET can be estimated for a crop and is called crop evapotranspiration (ETc). Estimating ETc can help growers plan irrigation applications for the growing season. There are three main methods available for growers to estimate seasonal ETc.

1. Calculate ETc using a reference ET (ETo) and a crop coefficient (Kc).
2. Use seasonal ETc estimates provided by Fox Canyon Groundwater Management Agency.

### Option 1: Calculate ETc

Potential ETc can be calculated by multiplying the ET of a reference crop (ETo) by a crop coefficient (Kc). [ETo × Kc = ETc]

- ETo: Represents water use by a reference crop. In California, the reference crop is well-watered pasture grass. The following sources provide ETo estimates.
  - CIMIS provides historical ETo: <https://cimis.water.ca.gov/Default.aspx>
  - FRET provides daily and weekly ETo forecasts: <https://digital.weather.gov/>
- Kc: A crop coefficient helps account for the difference in water use between the reference crop and your crop. Kc changes with crop type and growth stage. The following sources provide Kc values for annual and perennial crops.

  - Commodity specific research or industry boards

#### Lemons in Saticoy

$$Kc \times ETo = ETc$$

$$0.65 \times 40 = 26 \text{ applied inches}$$

### Estimating Crop Irrigation Rate

The crop irrigation rate for a field is based off the following components:

- Crop demand (ETc): water required by the crop to replace water lost through evapotranspiration
- Additional water requirements: water requirements in addition to the water required for crop demand. Requirements include water needed for leaching salts, germination, and climate control.
- Irrigation efficiency: water required to overcome any inefficiencies in the irrigation system

### Additional Water Requirements

---

In addition to crop demand there are other water requirements in an agriculture field. These requirements may include water needed for leaching salts, germination, and/or climate control. If there are additional requirements be sure to account for them when estimating the maximum irrigation rate for the season.

#### Leaching Salts

High salinity levels in the root zone reduce the crop's ability to take up water from the soil. Eventually this can cause a decline in yield. Salts can build up in the soil from applications of fertilizers, soil amendments like manure, and poor-quality irrigation water.

Leaching is the process of moving salts below the rootzone with water. Leaching should be conducted when soil nitrate levels are low to avoid moving large amounts of nitrate into groundwater.

## Leaching Requirement

The leaching requirement (LR) is the amount of excess water that needs to be applied to move salts below the rootzone. The LR can be calculated based on the average salinity of the water ( $EC_w$ ) and the soil salinity threshold ( $EC_e$ ) of the crop. For a list of soil salinity thresholds ( $EC_e$ ) for common crops visit:

$$LR (\%) = (EC_w \times 100) \div [(EC_e \times 5) - EC_w]$$

## Estimating Max Irrigation Amount

---

Once the crop demand, additional water requirements, and irrigation efficiency level have been determined growers can estimate the anticipated crop irrigation amount for the season.

$$\text{Max Amount} = \frac{(ET_c \div IE) - ER}{1 - (LR \div 100)} + \text{additional requirements}$$



## Calculating Irrigation Set Times

---

Once the desired water application has been determined in inches, growers must translate that into a system run time. Irrigation run times can be calculated based on flow meter data or system application rates.

### Flow Rate to Run Time

If you have a flow meter installed, irrigation set times can be determined based on the flow rate. To determine the hours of run time, use the equation below or use the calculator available at: <http://irrigation.wsu.edu/Content/Calculators/General/Set-Times.php>

$$\text{Time (hr.)} = \frac{\text{water application (in)} \times \text{area (acres)} \times 43,560}{96.3 \times \text{flow rate (gpm)}}$$

### Application Rate to Run Time

If you do not have a flow meter installed, irrigation set times can be determined based on the system application rate. To determine the application rate of a drip or sprinkler system use the equations or calculator available at: <http://irrigation.wsu.edu/Content/Calculators/Popular.php>

$$\text{Run Time (hr)} = \text{water application (in)} \div \text{application rate (in/hr)}$$

## Irrigation Water Testing

---

An irrigation water suitability test will provide growers with the concentrations of several elements in their water including nitrate-nitrogen (NO<sub>3</sub>-N). Different agricultural labs may have variable sampling methods and instructions. Growers should consult with their lab prior to collecting and sending in samples.

Growers can also use nitrate quick test strips or similar tools to estimate the concentration on-farm. However, it is important to understand strips can vary in accuracy when compared to laboratory testing.

### Collecting Water Samples

Below are some general guidelines for collecting water samples for on-farm or lab analysis. It is recommended that you contact an agricultural lab prior to collecting and submitting samples. Many labs provide free sampling bottles, guidelines, and any specialized equipment.

1. Allow irrigation well to run for 30 minutes
2. Take sample prior to injection stations
3. Fill container completely with water (no air gap)
4. Label container based on lab's instructions
5. Keep sample cold during shipment until delivery and deliver within the time frame specified by the lab

# Estimating Nitrate-Nitrogen

## Recording the Results

Depending on the lab or nitrate quick test strips used, results may be reported as mg/l Nitrate (NO<sub>3</sub>) or mg/l Nitrate-Nitrogen (NO<sub>3</sub>-N). If results are reported as mg/l Nitrate (NO<sub>3</sub>) a quick conversion can be completed.

## Converting the Results

$$\text{ppm NO}_3 \times 0.23 = \text{ppm NO}_3\text{-N}$$

or

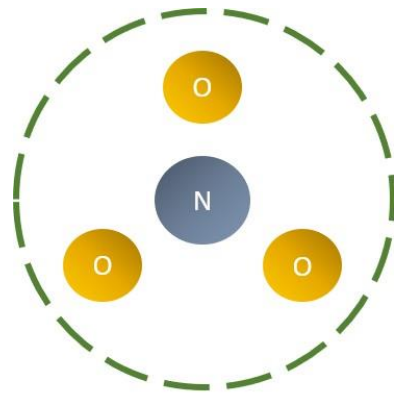
$$\text{mg/l NO}_3 \times 0.23 = \text{mg/l NO}_3\text{-N}$$

note: ppm = mg/l

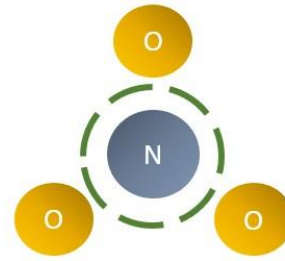

### Irrigation Efficiency (IE)

Irrigation efficiency (IE) is the percentage of applied water that is beneficially used. Two of the main factors that influence irrigation efficiency are irrigation scheduling and irrigation maintenance.

### Irrigation Scheduling

---

Irrigation scheduling methods can help growers know when to irrigate and how much water to apply with each irrigation event. There are three main methods covered below. A skilled irrigator will use a combination of available methods as each method has its weaknesses.

#### Soil Moisture Monitoring

Soil moisture monitoring can estimate how much water is available to the crop. Monitoring soil moisture can help growers decide when to irrigate.

Soil moisture sensors show when enough soil moisture has been depleted to warrant an irrigation event. Sensors can also indicate when enough water has been supplied to replace depleted moisture. Two general types of sensors are available: sensors that measure how tightly water is held by the soil (tension) and sensors that estimate the soils moisture content. Sensors that estimate moisture content can be used to estimate available water in the dormant season.

Devices that measure tension include tensiometers and electrical resistance blocks (also known as gypsum blocks). Devices that measure soil moisture content include neutron probes and dielectric soil moisture sensors.

### **Plant Based Monitoring**

Plant-based monitoring can estimate plant water stress to help growers decide when to irrigate. Plant-based monitoring is the ultimate indicator of whether a plant needs water. However, plant-based methods cannot determine how much water to apply.

Devices that take direct measurements of stress include the pressure chamber, automated water potential sensors, and sap flow sensors. Devices that take indirect measurements, like dendrometers, monitor the shrinkage and swelling of the trunk or petiole.

### **Weather Based Monitoring**

Weather-based irrigation scheduling uses crop ET estimates to help determine when to irrigate and how long to run the irrigation system. Each irrigation event should be scheduled to replace the water used by the crop since the last irrigation event. Thus, preventing overirrigation and leaching of nitrate.

Weather-based methods should only be used as an irrigation guide. Plant-based and/or soil-based methods should be used as a check.

## **Irrigation Maintenance**

---

Maintaining an irrigation system is essential to ensuring uniform applications and irrigating efficiently. Below are several key maintenance tasks that should be performed throughout the season.

- Clean and inspect media tanks, screen, and filters
- Inspect any electronic devices, like flow meters and pressure transducers
- Inspect system for leaks or damage

### **Irrigation Maintenance II**

- Check emitters and hose screens for plugging
- Flush lines
- Check system pressure

## **Other Efficiency Practices**

---

There are several other practices that can improve the irrigation efficiency of a field or irrigation system. Some of those practices include:

- Laser leveling
- Variable frequency drives, allowing the pump to respond smoothly and efficiently to fluctuations in flow and/or pressure demands
- Using pressure-compensating emitters with drip and microsprinkler systems

## Expected Yield

The projected yield is used to calculate nitrogen requirements for annuals and mature perennial crops. Thus, it is important to provide a realistic yield estimate.

### Overestimating Yield

Overestimating yield can lead to an overapplication of nitrogen. If field or weather conditions are indicating yields may be lower than predicted, in-season adjustments to nitrogen application rates should be made.

### Method 1: Estimate based on Cropping History

A realistic yield estimate can be made by averaging yields from the previous 3-5 seasons. Unusually bad or good years can be omitted from the average. Additionally, adjustments should be made based on knowledge of field and market conditions.

### Method 1 Example: Fresh Market Carrots

A grower has 5 years of data from their fresh market carrot field. In year one, they experienced unusually low yields. Omitting data from year one, what is the average yield?

- 580 crates, 640 crates, 630 crates, 680 crates, 650 crates
- Average = 650 crates per acre



## Method 2: Estimate based on County Crop Reports

If there is no crop history available for a field or management unit, an estimate can be made based on county crop reports. This method of estimation is most accurate for annual crops.

1. Locate county crop reports: <https://www.ventura.org/agricultural-commissioner/reports/>
2. Average yields from previous 3-5 seasons
3. Adjust as needed for current field conditions

### Column (B) Actual Harvest Yield

Nitrogen removed is calculated using reported yield and a nitrogen removal coefficient. Thus, reporting an accurate yield will ensure an accurate evaluation of nitrogen applied vs. removed.

## **Additional Yield Information**

---

In the INMR there is a box to provide additional information on yield for a management unit. Growers should provide information in this box if there was no yield, or the field was non-bearing or not farmed. This would also be a good location to note any significant yield loss or difficulty in quantifying yield.

## Nitrogen Use Efficiency

---

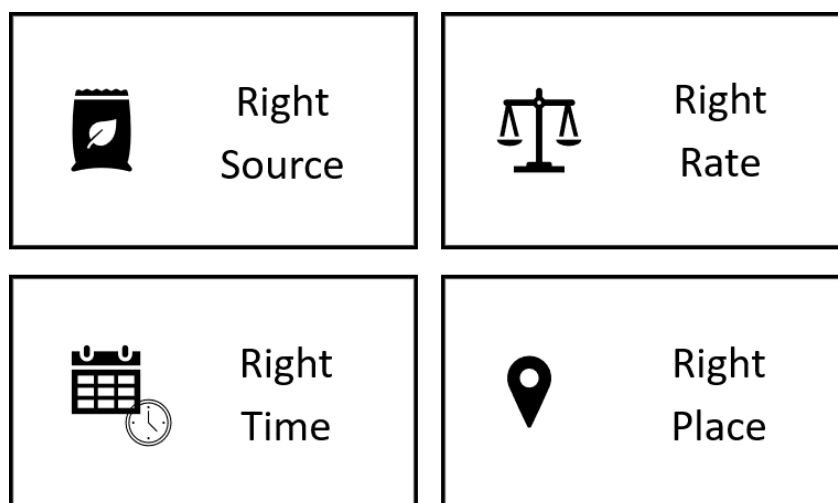
Nitrogen use efficiency is a measure of how well available nitrogen matches nitrogen uptake. Globally, the average nitrogen use efficiency level is 50%. However, with the adoption of efficient irrigation and nitrogen management practices in California agriculture, 70% efficiency is achievable. A 70% nitrogen use efficiency means that 70% of the nitrogen available to the crop was taken up by the crop.

## 4Rs of Nitrogen Management

---

Improving nitrogen use efficiency can increase yields, profitability, and reduce the environmental impacts of nitrogen loss.

Nitrogen use efficiency can be improved by following the 4R principles, applying the right source at the right rate, the right time, and in the right place.



### Right Source

Selecting the right nitrogen source can be a complex decision that involves considering crop requirements, soil conditions, application method, and product price. It is also important to know what form the nitrogen is in. The form of nitrogen will influence how the input behaves in the soil and when the nitrogen will be available for plant uptake.

### Examples of Right Source

- Selecting a source based on when the nitrogen will be available to the plant
- Selecting a nitrogen fertilizer that is less susceptible to atmospheric or leaching loss

## **Right Rate**

Ensure that the amount of nitrogen available to the crop is sufficient to meet crop demand. Nitrogen rates beyond crop need can result in nitrogen loss. Excess nitrogen can also increase pest and disease pressure.

### Examples of Right Rate

- Use soil and tissue/petiole testing to adjust seasonal application rates
- Adjust nitrogen application rates based on expected crop yield
- Adjust nitrogen fertilizer application rates to account for nitrogen from other sources such as residual soil nitrate, organic amendments, and irrigation water

## **Right Time**

Nitrogen applications should be timed to ensure that nitrogen will be available to the plant during periods of high demand. In annual crops, nitrogen demand is highest during the vegetative growth stage. In mature trees and vines, nitrogen demand is typically highest during early fruit and nut development.

### Examples of Right Time

- Split nitrogen applications to match the crop's nitrogen uptake curve
- Delay nitrogen applications until just before periods of high demand

## **Right Place**

For uptake to occur, applications should be targeted to ensure that nitrogen is available in the crop's effective rootzone. The effective rootzone is the depth of soil where most plant roots obtain moisture and nutrients. A crop's effective rootzone depends on the crop type, development stage, and irrigation system.

### Examples of Right Place

- Planning fertilization events to ensure nitrogen stays in the rootzone
- Using banding or fertigation methods where appropriate to target applications near the effective rootzone
- Incorporation or watering in fertilizers that are prone to ammonia volatilization when left on the soil surface

## Soil Available Nitrogen

---

### INMP Worksheet Box 11

In the nitrogen management section of the INMP Worksheet, Box 11(A) asks growers to record nitrogen available to the crop from the soil. This value is only required under column (A) to inform N recommendations and planning.

### Soil Available Nitrogen

Available nitrogen in the soil can be a significant source of nitrogen in annual cropping systems. Thus, it should be accounted for in the nitrogen budget. For orchards and vineyards, available nitrogen in the soil is not typically accounted for in a nitrogen budget. So, it is appropriate to enter a zero in Box 9A and 9B for these systems.

### Residual Soil Nitrate

Available nitrogen in the soil is also known as residual soil nitrate. Residual soil nitrate may include:

- nitrogen left over from the previous crop
- nitrogen from recent fertilizer or irrigation applications
- nitrogen mineralized from crop residues and soil organic matter

## Taking Representative Soil Samples

---

### Soil Sample Timing

A soil nitrate test provides a snapshot of the nitrate available in the soil at the time of sampling. Thus, soil samples should be collected close to a planned fertilizer application.

### Soil Sample Location

It is important to ensure soil samples are representative of the conditions across a field or management unit. A minimum of 20 soil cores should be collected from each field or management unit in a zigzag or “X” shaped pattern. For drip irrigated annual crops, angle the probe in the direction of the drip tape.

## Soil Sample Depth

Soil samples should be collected from the top 1 to 2 feet of soil, depending on the crop rooting depth and architecture. Remove residues from the surface of each sample. Then, mix samples thoroughly in a bucket.

## Handling Soil Samples

If growers are sending samples to a lab for analysis, they should be kept cool and delivered to the lab promptly. If this is not possible the samples should be quickly air dried or frozen to prevent further nitrogen mineralization.

## Estimating Soil Available Nitrogen

---

### Test Results

Soil nitrate test results may be reported in ppm nitrate or ppm nitrate-N. To complete Box 11 on the INMP Worksheet, results will need to be converted to lbs. of nitrogen available per acre.

### Converting Test Results

Step 1: Convert ppm nitrate to ppm nitrate-N

$$\text{ppm nitrate} \times 0.23 = \text{ppm nitrate-N}$$

Step 2: Convert ppm nitrate-N to lbs. of nitrogen per acre

$$\text{ppm nitrate-N} \times 4^* = \text{lbs. nitrogen per acre in the top 12 in of soil}$$

$$\text{ppm nitrate-N} \times 8^* = \text{lbs. nitrogen per acre in the top 24 in of soil}$$

\*In organic soils, the conversion factors are 3 and 6 due to a lower bulk density.

### Activity 5.2.1

## Soil Nitrate Quick Test

---

For routine field monitoring in annual cropping systems, an on-farm nitrate quick test can be completed. Quick test values tend to underestimate nitrate-N concentrations compared to lab methods, particularly for lower concentrations of nitrate-N. While results are not as accurate as a lab analysis, on-farm testing offers quick results that can be helpful for in-season adjustments.

The University of California Agriculture and Natural Resources Division has a set of resources to guide users in completing and understanding a soil nitrate quick test. The resources include an interactive step-by-step guide, an instructional video, and a tool developed to help growers interpret the results. The web-based tool utilizes NRCS soil survey data to provide a lab equivalent value and an estimate of lbs. of nitrogen available per acre.

### Availability of Nitrogen in Irrigation Water

Nitrogen in irrigation water is as effective as nitrogen applied in inorganic fertilizers. Thus, all nitrogen applied through the irrigation water must be accounted for on the INMP Worksheet.

### Box 10(A) Pre-Season Planning

---

An estimate for the season can be made using the anticipated crop irrigation rate (Box 2) and the nitrate-N concentration of the irrigation water (Box 3).

$$\text{lbs. nitrogen/acre} = \text{Box 3} \times 0.23 \times \text{Box 2}$$

$$\text{lbs. nitrogen/acre} = \text{ppm nitrate-N} \times 0.23 \times \text{in. of water}$$

### Box 10(B) Post Season Actuals

---

The actual nitrogen applied to the field during the season is based on the actual irrigation application rate and the nitrate-N concentration of the irrigation water (Box 3).

$$\text{lbs. nitrogen/acre} = \text{Box 3} \times 0.23 \times \text{in. of water applied}$$

$$\text{lbs. nitrogen/acre} = \text{ppm nitrate-N} \times 0.23 \times \text{in. of water applied}$$

## Determining Applied Water

### Activity 5.3.1

What method do you use to determine how much water you applied over the season?

#### Option 1: Based on Flow Meter Totalizer Data

The totalizer on a flow meter can be used to determine the total amount of water pumped between two points in time. Reading (End of Season) - Reading (Beginning of Season) = total amount of water pumped.

Most meters will report data in gallons or ac-ft. Use the equations below to convert to inches of water applied per acre.

$$\text{in/ac} = \text{gallons} \div 27,154 \div \text{acres}$$

$$\text{in/ac} = (\text{ac-ft} \times 12) \div \text{acres}$$

#### Option 2: Based on System Application Rate and Duration

Applied Water (in/ac) = [application rate (in/hr.) x hours of operation] ÷ acres

If system application rate is unknown the following resources can be used.

### Organic Amendments

Organic amendments include natural sources of carbon and nutrients that do not have a guaranteed nutrient content. Below are examples of common organic amendments:

- Plant and Animal Based Compost
- Animal Manure (i.e., cow, swine, chicken)
- Animal Based Fertilizers (i.e., bloodmeal, feathermeal, guano, pelleted chicken manure)
- Plant Based Fertilizers (i.e., soybean, cottonseed, and alfalfa meals)
- Cover Crop and Crop Residues

### Plant Available Nitrogen

---

Organic amendments contain mostly unavailable organic forms of nitrogen and small amounts of inorganic nitrogen (ammonium). The organic nitrogen in these materials must be transformed by soil microbes to be available to the plant.

How quickly the organic nitrogen becomes available to the plant depends on soil temperature and moisture, the C:N ratio of the amendment, and the level of incorporation into the soil.

## Nitrogen Availability

Amendment	C:N Ratio	N Available after 12 weeks
Yard Waste Compost	13 – 20	<10%
Poultry Manure & Manure Compost	6 – 8	30 – 40%
Blood & Feather Meal, Guano	3 – 4	60 – 75%
Cover Crop Residue	12 – 18	4 – 35%
Vegetable Crop Residue	<15	4 – 45%

Pictured is a table of common organic amendments, their C:N ratio and how much nitrogen is typically available from the amendment after 12 weeks in the soil.

## Estimating Nitrogen Contribution from Organic Amendments

---

### Using the Organic Amendment Calculator

The calculator estimates nitrogen availability for the following amendments:

- Feather Meal
- Blood Meal
- Guano
- Poultry Manure
- Poultry Manure Compost
- Pelleted Material
- Vermicompost
- Yard Waste Compost

To use the calculator, growers input the region, type of amendment, application date, application rate, and depth of incorporation. Additional information can be put into the calculator if known including %dry matter, %N, and the C:N ratio.

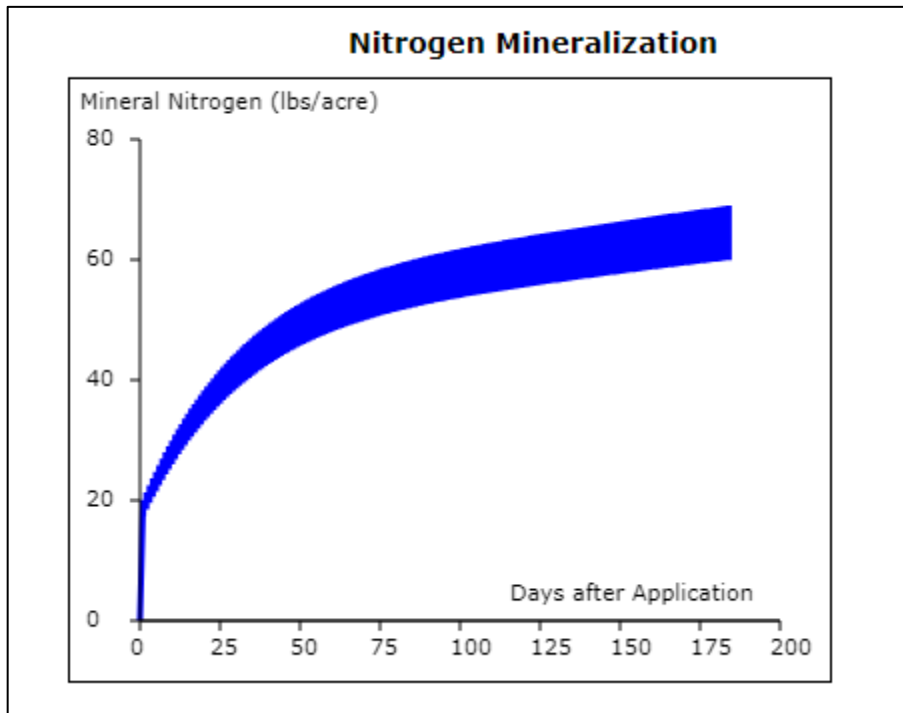

  - Inputs required: previous crop yield, %N of residue, and expected N in the crop residue
- Composts (Part 3, E1)
  - Inputs required: application rate, %N and % water

### Fertilizer Labels

A typical fertilizer label contains a grade and guaranteed analysis. The grade shows the percentage of nitrogen (N), phosphate (P<sub>2</sub>O<sub>5</sub>), and potash (K<sub>2</sub>O). The guaranteed analysis is the manufacturer's guarantee that the product contains the nutrients at the listed percentage.

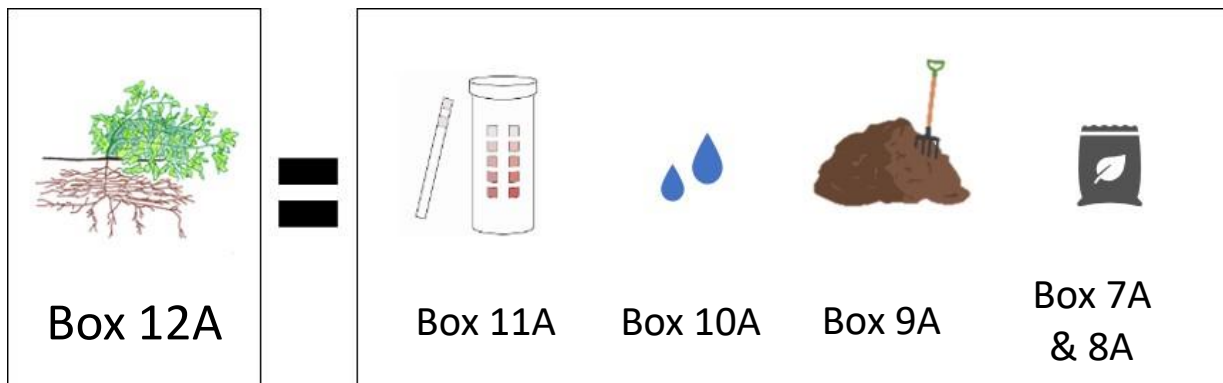

**Box 7(A) Pre-Season Planning**

---

At the beginning of the season, growers must determine how much nitrogen to apply through granular/liquid fertilizers. The amount depends on the total nitrogen requirement of the crop (Box 12A) and nitrogen available from other sources (Boxes 9A – 11A).



Thus, Boxes 12A and 9A-11A should be completed prior to determining the amount of nitrogen to apply through granular/liquid fertilizer (Boxes 7A and 8A). Once the desired amount is determined, the fertilizer application rate can be calculated.

**Granular Nitrogen Fertilizer Calculation**

To determine the amount of granular fertilizer to apply, growers need to know the % N of the fertilizer. %N can be found on the fertilizer label.

$$\text{Fertilizer Application} = [\text{desired nitrogen rate (lb. N/ac)} \times 100] \div \% \text{ N}$$



### Liquid Nitrogen Fertilizer Calculation

To determine the amount of liquid fertilizer to apply, growers need to know the density and % N of the fertilizer. %N and fertilizer density (expressed in lbs./gallon) can be found on the label or on the manufacturer’s website.

$$\text{Fertilizer Application} = [\text{desired nitrogen rate (lb. N/ac)} \times 100] \div [\% \text{ N} \times \text{density}]$$

#### Activity 5.5.2

A grower needs to apply 50 lbs. of nitrogen fertilizer per acre. How many gallons of UAN 32 would they apply? (UAN 32 density = 11.0 lbs./gallon)

### Box 7(A) Post-Season Actuals

Once the season is over, growers need to report the amount of nitrogen applied through granular and/or liquid fertilizer applications.

#### Granular Fertilizer Calculation

To determine the amount of nitrogen in a granular fertilizer, growers need to know the % nitrogen and fertilizer application rate.

$$\text{N Applied} = (\% \text{ N} \div 100) \times \text{application rate (lbs./ac)}$$

#### Liquid Fertilizer Calculation

To determine the amount of nitrogen in a liquid fertilizer, growers need to know the fertilizer density, the % N and the application rate in gallons per acre.

$$\text{N Applied} = \text{fertilizer density (lbs./gal)} \times (\% \text{ N} \div 100) \times \text{application rate (gal/ac)}$$

#### Activity 5.5.3

Throughout the season, a grower applied 10 gallons of CAN 17 (density = 12.7 lbs./gal) per acre and 200 lbs. of granular urea (46-0-0) per acre. In total how much nitrogen was applied?

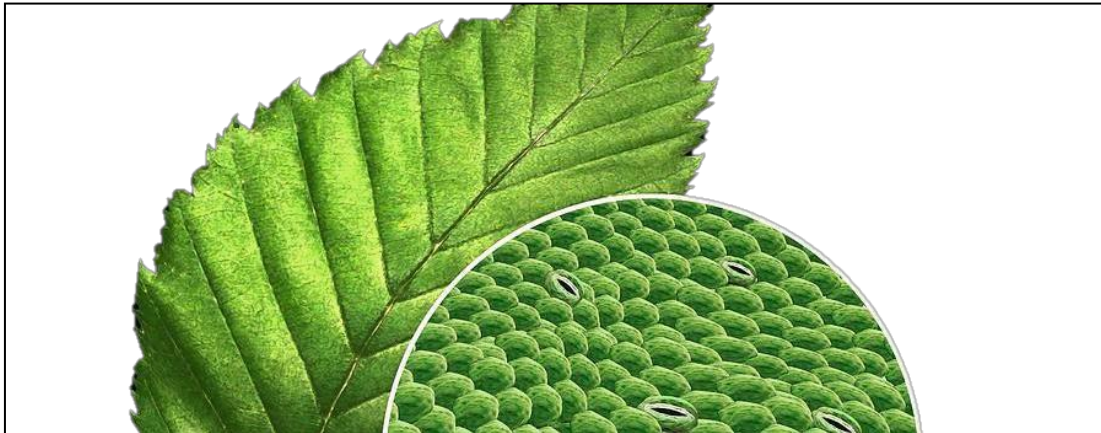

In the nitrogen management section of the INMP Worksheet, Box 8 asks growers to estimate and record nitrogen applied from foliar fertilizers. Box 8 has two columns, one for pre-season recommendations/planning (A) and one for actuals recorded at the end of the season (B).

### Application of Foliar Nitrogen Fertilizers

Plant leaves can absorb urea, ammonium, and nitrate through small pores called stomata. Absorption of foliar fertilizers is increased when sprays reach and coat the plant's leaves.



### Foliar Applications

The amount of material reaching the plant's leaves is affected by air temperature and moisture during application. To reduce evaporation, applications should be made in low temperatures or when the relative humidity is high. These conditions are most likely to occur in the early morning or evening. Additionally, adding a surfactant to the spray or using electrostatic sprayers can increase absorption rates.

## Use Caution

Highly concentrated sprays have the potential to “burn” plant tissues and cause crop damage. Thus, foliar fertilizers are often applied in dilute amounts.

## Foliar Fertilizer Recommendations

Foliar fertilizers are not a replacement for soil applied macronutrients but can be beneficial in certain circumstances. Foliar applications can be used as a supplemental source of nitrogen and may provide a small boost in growth or yield for some crops and varieties. For crop specific information on foliar fertilization visit the California Fertilization Guidelines.

## Foliar Fertilizer Calculations

---

### Box 8(A) Pre-Season Planning

To determine the amount of foliar fertilizer to apply, growers need to know the density and % N of the fertilizer. %N and fertilizer density (expressed in lbs./gallon) can be found on the label or on the manufacturer’s website.

$$\text{Application Rate} = [\text{desired nitrogen rate (lb. N/ac)} \times 100] \div [\% \text{ N} \times \text{density}]$$

### Box 8(B) Post-Season Actuals

To determine the amount of nitrogen in a foliar application, growers need to know the product density and %N, and the application rate.

$$\text{N Applied} = \text{fertilizer density (lbs./gal)} \times (\% \text{ N} \div 100) \times \text{application rate (gal/ac)}$$

If the application rate is in ounces use the following conversion rate: 128 oz/gal

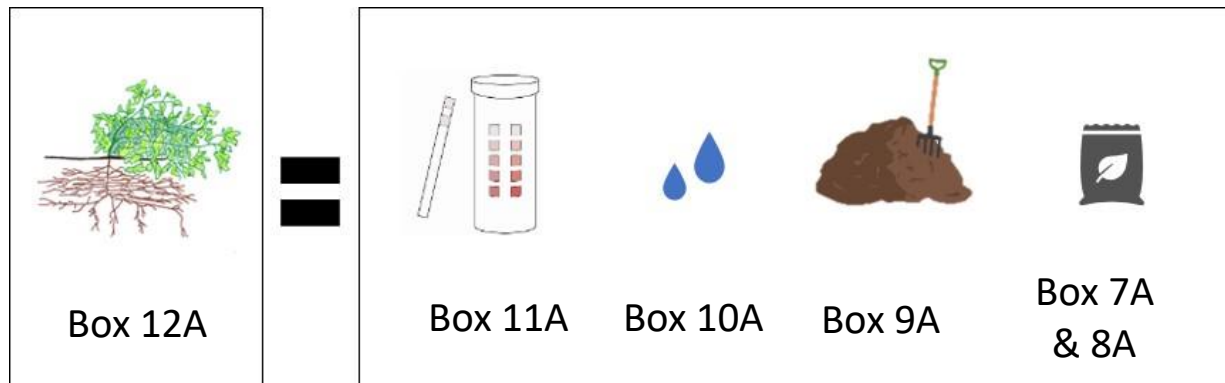

### Box 12(A) Pre-Season Planning

---

Box 12(A) is equal to the total nitrogen requirement of the crop. While it is the last box in the nitrogen management section, it should be completed prior to Boxes 7A-11A. Working backwards through the nitrogen management section of the INMP Worksheet will produce the best results.



### Estimating Nitrogen Required

There are several approaches to estimating the crop nitrogen requirement. In this training we will cover two common methods. Method 1 is based on the amount of nitrogen removed from the field with harvest and method 2 is based on recommended application rates from field research.

### Method 1: Nitrogen Removed with Harvest

Method 1 is the most appropriate for orchard crops. And for field and vegetable crops where the majority of crop residue is removed from the field during harvest.

#### Method 1 Calculation

In method 1, the crop nitrogen requirement is determined by multiplying estimated yield (Box 5) by a nitrogen removal coefficient. The results are then divided by the expected nitrogen use efficiency (NUE). An achievable NUE for California agriculture is 0.7. A list of nitrogen removal coefficients can be found on VCAILG's Irrigation and Nutrient Management Plan webpage at <https://www.farmbureauvc.com/vcailg/>.

$$\text{Total N} = \frac{(\text{Expected Yield} \times \text{N Removal Coefficient})}{\text{NUE}}$$

For some mature orchard crops, an additional amount of nitrogen is needed for perennial tissue growth. This amount is typically between 10-40 lbs. of nitrogen per acre. Unless indicated, the perennial growth requirement is included in the nitrogen removal coefficient.

$$\text{Total N} = \frac{[(\text{Expected Yield} \times \text{N Removal Coefficient}) + \text{N for perennial growth}]}{\text{NUE}}$$

#### Activity 5.7.1

Calculate the pounds of nitrogen needed per acre for a 10-year-old avocado orchard:

- Expected yield= 2.75 tons/ac.
- N Removal coefficient= 4.4 lbs. N/ton of avocados
- Perennial growth requirement = 15 lbs. N/ac

$$\text{Total N} = \frac{[(\text{Expected Yield} \times \text{N Removal Coefficient}) + \text{N for perennial growth}]}{\text{NUE}}$$

### Method 2: Recommended Application Rates from Research

Method 2 is the most appropriate for field and vegetable crops where a significant amount of crop residue is left in the field following harvest. Method 2 is also appropriate for young orchards.



In method 2, the crop nitrogen requirement is based on California field research. Many resources provide recommended nitrogen rates including the California Fertilization Guidelines.

Total N = Crop Nitrogen Requirement

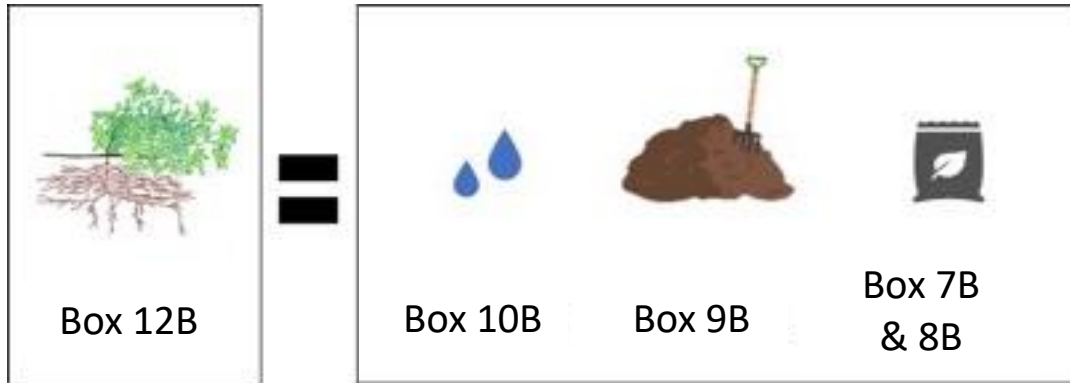
**Example**

A strawberry grower estimates their yield will be 36 tons/acre. Using the California Fertilization Guidelines, the grower finds that the total nitrogen requirement is approx. 200 lbs. per acre.

## Box 12(B) Post-Season Actuals

---

Following harvest, total nitrogen applied (Box 12B) can be calculated by adding together all nitrogen inputs (Boxes 7B-10B).

## Nitrogen Applied vs. Nitrogen Removed

---

The Regional Water Quality Control Board is interested in knowing how much nitrogen is being applied to a field (A) versus how much nitrogen is being removed from the field (R). A/R and A-R are used as metrics to determine the potential for nitrogen loss.

Calculating A/R or A-R is not required for the INMP Worksheet or INMR. However, growers can use this information to make informed decisions regarding nitrogen management. The A/R and A-R will be calculated by the Coalition and included in reports required by the Regional Water Board.

### Nitrogen Applied (A)

Nitrogen from the following sources is considered when calculating nitrogen applied (A) for the A/R and A-R metrics:

- Irrigation Water (Box 10)
- Organic Amendments (Box 9)
- Dry/Liquid Fertilizers (Box 7)
- Foliar Fertilizers (Box 8)

### Nitrogen Removed (R)

Nitrogen removed (R) from the field with harvested plant parts is based on the crop yield and a nitrogen removal coefficient. List of Draft Nitrogen removal coefficients are available for crops covering 92% of acreage in Ventura County. Research is currently underway to provide reliable coefficients for additional crops.  $(R) = \text{yield} \times \text{nitrogen removal coefficient}$

### Calculating A/R and A-R

---

Once a grower has calculated nitrogen applied (A) and nitrogen removed (R) for the season, A/R and A-R can be calculated.

#### Interpreting A/R Values

A/R < 1: more nitrogen was removed from the field with harvest than was applied

A/R = 1: the same amount of nitrogen that was applied to the field was removed with harvest

A/R > 1: more nitrogen was applied to the field than was removed with harvest

The greater the A/R value, over 1, the more potential for nitrogen loss and decreased profit. A/R values are compared across fields with the same crop in each area. Fields with a larger A/R value may be identified as statistical outliers warranting additional reporting requirements.

## INMP Worksheet Certification


---

The last section of the INMP Worksheet covers certification. All growers are required to certify their INMPs, with the exception of growers with total farming operation acreage less than 10 acres and has not been identified as an outlier. However, growers qualifying for this certification exemption are still required to develop an INMP and submit an INMR.

### Certification Section

The person certifying the plan must complete the INMP Certification section including signature, date, and method of certification. The plan certifier should also initial the box in the bottom right corner of the INMP Worksheet.

### Certification Options and Requirements

---

INMP Worksheets can be certified by a Certified Crop Advisor, a Technical Service Provider with NRCS, or self-certified by an eligible grower.

#### Option 1: CCA

INMP Worksheets may be certified by a Certified Crop Advisor (CCA) certified by the American Society of Agronomy

#### Option 2: NRCS

INMP Worksheets may be certified by NRCS through one of two pathways:

- Certified by a Technical Service Providers certified in nutrient management in California by the National Resource Conservation Service (NRCS)
- Self-Certified by a grower who follows a site-specific recommendation from NRCS (documentation required)

### Option 3: Self-Certification

To be eligible to self-certify INMP Worksheets through the CDFA Training Program, a grower must complete the Irrigation and Nitrogen Management Training and Exam and participate in continuing education courses.

Once a grower has taken the Irrigation and Nitrogen Management Training and passed the exam, they are eligible to self-certify INMP Worksheets for their farming operation(s).

### Continuing Education

To maintain the eligibility to self-certify INMP Worksheets, growers must participate in 3 hours of continuing education every 3 years. To count towards the continuing education requirement, courses must be approved by the California Department of Food and Agriculture. Approved courses will be advertised with “CDFA INMP Credits”. Courses focus on irrigation and/or nitrogen management. For a list of approved courses visit:

## INMR

---

The INMR was designed to help monitor nitrogen applied and removed from the field through harvest. Many of the components on the INMP Worksheet are transferred to the INMR. Transferred information is marked on the INMP Worksheet with an asterisk \*.

Data from multiple INMP Worksheets can be reported in one INMR.

### INMR Sections

The Summary Report has three main sections:

1. Management Unit (MU) and Parcel Inventory
2. General Information and Irrigation and Nutrient Management Report
3. Irrigation and Nutrient Management Practices

### Section 1: Field and Parcel Inventory

---

Section 1 pulls information from the Parcel Management Section of the associated INMP Worksheet(s).

#### Management Unit and Parcel Inventory

Populate the table with all parcels covered in the INMR.

Enter 0 irrigated acres if the parcel or management unit was left fallow or was not in production for the reporting period.

Additionally, there is a comment section to report any abnormalities that may have occurred during the reporting period. This can include fields that were not harvested or experienced stress that may have impacted yields like drought or pest damage.

To complete the INMP Summary Table, enter the Management Unit, Crop, Crop Age, and Total Irrigated Acres from the Parcel Inventory Sheet. Then complete the table using Post- Season Actuals from Column (B) of the INMP Worksheet.

The data reported in this table is used to calculate A/R and A-R. Thus, it is important to ensure all the information reported is accurate. If you do not apply nitrogen fertilizer to your fields, you are still required to submit n INMR. Please enter a zero for nitrogen applied.

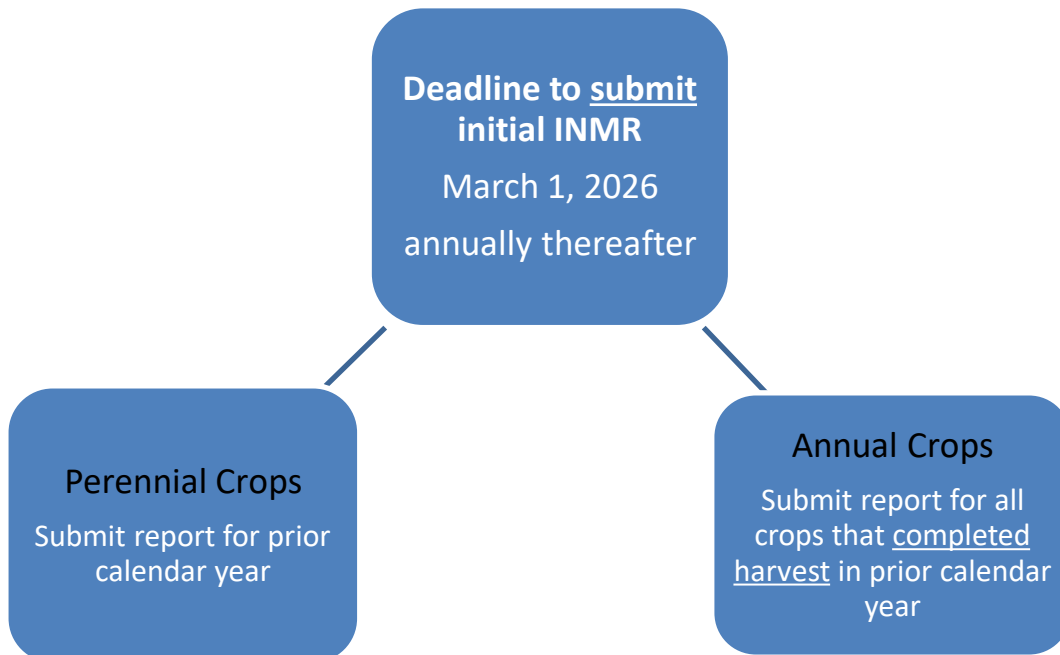

Each section heading below (all CAPS) corresponds to the section heading on the INMP Worksheet. The numbered references correspond to each numbered box on the INMP Worksheet. **Items with an asterisk shall be submitted to VCAILG on the Irrigation and Nutrient Management Report (INMR).**

### MEMBER INFORMATION

- Enter the Ventura County Agricultural Irrigated Lands Group (VCAILG) membership identification number (**Member ID#**) and the **Member Name** associated with this membership.

### MANAGEMENT UNIT INFORMATION

**\*Items with an asterisk shall be submitted to VCAILG on the INMR.**

- Enter the **Management Unit ID\*** for the Management Unit that you are writing the plan. A Management Unit is defined as a contiguous piece of land that has the same crop that is also the same age and managed with the same irrigation and fertilization program. For nurseries, a Management Unit can be a single contiguous location.
- Enter the **Crop Year (Harvested)**. Information on INMP Worksheets should be based on the calendar year in which harvest was completed. This includes winter crops (i.e. berries, rotational vegetables, and some citrus crops such as navel oranges) for which fertilization may have occurred in the previous calendar year but harvest was completed in the following calendar year. Fertilization does not need to occur within the same calendar year to be considered a part of the current crop year.
- Enter the **Crop Type\***. Check with VCAILG for questions regarding specific crop naming conventions. If you have a permanent crop, enter the **Crop Age (Perennial Only)\*** in years.
- Indicate if the Management Unit you are writing the plan for was identified as a **Statistical Outlier\*** by VCAILG for the previous crop year. VCAILG conducts a statistical analysis on the data provided from members for the nitrogen applied and nitrogen removed (based on yield) to determine statistical outliers. VCAILG provides annual feedback to members on reported nitrogen use including if the Management Unit was identified as a statistical outlier. If the Management Unit was identified as a statistical outlier in the previous crop year, mark "Yes". Contact VCAILG for any questions about this notification and statistical outliers.

- **Crop Evapotranspiration (1).** Enter the potential crop evapotranspiration (ETc) in inches anticipated for the season. Evapotranspiration rates are provided by geographical location and multiplied by a crop-specific coefficient to estimate the amount transpired by your crops. Refer to Module 3 Lesson 3 in your workbook for guidance on estimating potential crop ETc.
- **Anticipated Crop Irrigation (2).** Enter the amount of irrigation water in inches expected to be applied over the course of the season.
- **Irrigation Water N Concentration (3).** Enter the concentration of nitrogen in the irrigation water used on your crop as parts per million (ppm) or milligrams per liter (mg/L). The concentration of nitrogen in your irrigation water can be obtained from sources such as local district testing, laboratory analysis, or other sources. These results can be reported as either Nitrate as N, nitrate-nitrogen, or NO<sub>3</sub>-N.
- **Production Unit\* (4).** This is the standard unit that is the basis for your nitrogen management planning (tons, pounds, bins, cartons, bales, etc.); refer to your Coalition for specific production unit lists. If you use a production unit that is not pounds or tons, please provide the weight of the reported unit (i.e. "28 lb lug boxes" instead of "lug boxes"), as crops often have multiple possible harvest production units.
- **Projected Harvested Yield (5).** This is the anticipated crop yield for the season, most commonly based off prior harvest yields for the Management Unit. The Projected Harvest Yield should be reported on a per-acre basis for the Management Unit covered by the plan.



- **Note:** Box (6) has been omitted from the current INMP version, please proceed with Section 2, box 7.

## SECTION 2: NITROGEN MANAGEMENT

**\*Items with an asterisk will need to be submitted to the Coalition on the INMR.**

**Recommended/Planned N (Column A):** Complete the boxes in Section 2: Nitrogen Management in **Column A** based on the anticipated Nitrogen Sources required to obtain the **Total Nitrogen Recommended (12A)**. The values listed in Column A require certification. Use crop recommendations from CDFA, UCCE, NRCS, commodity organizations or site-specific knowledge to appropriately estimate the amount of nitrogen (N) necessary. Use Recommended/Planned N totals for each source of N and schedule applications for the crop year. Use additional tools/spreadsheets to plan timing for each application. Proper scheduling of N applications and irrigations is essential for efficient nitrogen management.

**Recommended / Planned TOTAL NITROGEN (12A):** All Nitrogen Sources in this section should be the total for **Recommended / Planned TOTAL NITROGEN (12A)**.

$$\text{Recommended / Planned TOTAL NITROGEN (12A)} = 7A + 8A + 9A + 10A + 11A.$$

Complete the following sections based on the nitrogen source:

- **Dry/Liquid Fertilizer N (7A and 7B\*).** The Dry/Liquid Fertilizers include any nitrogen- containing product with a guaranteed nutrient content. This number should be reported as the amount of nitrogen applied as pounds per acre; this may be different than the amount of fertilizer applied which may include other nutrients.
- **Foliar Fertilizer N (8A and 8B\*).** Foliar nitrogen applications include any nitrogen-containing product applied to the crop canopy or above ground plant parts, and should be reported in pounds per acre.
- **Organic Amendments (9A and 9B\*).** Organic Amendments include any nutrient applications from sources that do not have a guaranteed nutrient content, such as compost and manure applications. Applied organic amendments should be reported as the amount of nitrogen available to the plant during the crop year, in pounds per acre.
- **N in Irrigation Water (10A and 10B\*).** Enter the amount of nitrogen applied via irrigation water over the course of the crop year in pounds per acre. For planning **(10A)**, this value is calculated based on the **Anticipated Crop Irrigation (2)** and the **Irrigation Water N Concentration (3)**. For the Actual N column **(10B)**, this value is calculated based on the actual crop irrigation and irrigation water N concentration. To calculate N in irrigation water, use the following formula:

$$\text{N concentration (ppm or mg/L)} \times \text{inches of irrigation applied} \times 0.226$$

Nitrate as nitrogen is also referred to as Nitrate as N, nitrate-nitrogen, or  $\text{NO}_3\text{-N}$ .

- **Soil – Available N in Root Zone (11A).** Represents nitrogen in the soil root zone that is available to the crop during the growing season. Enter the amount of residual soil nitrogen based on soil samples or other available data.
- **Actual N (Column B)\*:** Fill in the **Actual N (Column B)** based on actual applied nitrogen amounts. This should be completed after the crop is harvested for each of the nitrogen sources outlined above. These values do not require certification. Use the Recommended/Planned N schedule to guide nitrogen



applications throughout the growing season. Actual application amounts and timing can be adjusted based upon changing conditions (weather, pest damage, expected yield, tissue samples, etc.). The information in this column should reflect the actual application during the Crop Year. Refer to the Nitrogen Source section above for additional instructions and definitions.

- Actual TOTAL NITROGEN (12B): Actual applied Nitrogen Sources should be the total for Actual TOTAL NITROGEN (12B).

$$\text{Actual TOTAL NITROGEN (12B)} = 7B^* + 8B^* + 9B^* + 10B^*$$

- Self-Certified by Member who has attended the California Department of Food and Agriculture (CDFA) or other approved training program for INMP certification. The Member must retain written documentation of their attendance in the training program.
- Self-Certified by Member who adheres to a site-specific recommendation from the Natural Resources Conservation Service (NRCS Nutrient Management Plan). The Member must retain written documentation of the recommendation.
